Ordinance No. 5049

AN ORDINANCE RELATING TO HISTORIC PRESERVATION; AMENDING ORDINANCE NO. 5043 OF THE CITY OF LAS VEGAS AND SECTION 19A.06.090(E) OF THE ZONING CODE OF THE CITY OF LAS VEGAS, ADOPTED AS AND INCORPORATED IN TITLE 19A OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO CORRECT AN OMISSION IN ORDINANCE NO. 5043 BY PROVIDING THAT ONE OF THE SEATS ON THE CITY'S HISTORIC PRESERVATION COMMISSION BE FILLED BY A PERSON WHO IS EXPERIENCED IN NEVADA HISTORY; PROVIDING FOR OTHER MATTERS RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Corrects an omission in Ordinance No. 5043 by providing that one of the seats on the City's Historic Preservation Commission be filled by a person who is experienced in Nevada history.

The above and foregoing ordinance was first proposed and read by title to the City Council on the 26TH day of January, 1998 and referred to the following committee composed of Councilmen Brown and McDonald for recommendation; thereafter the said committee reported favorably on said ordinance on the 9th day of February, 1998, which was a regular meeting of said City Council; and that at said regular meeting the proposed ordinance was read by title to the City Council as first introduced and adopted by the following vote:
