AN ORDINANCE RELATING TO GRADING PERMITS; AMENDING THE SUPPLEMENTAL DOCUMENT AMENDING THE UNIFORM BUILDING CODE, 1994 EDITION, REFERRED TO IN TITLE 16, CHAPTER 4, SECTION 10 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1983 EDITION, BY ADDING TO SECTION 3309 OF THE APPENDIX A NEW SUBSECTION, DESIGNATED AS SUBSECTION 3309.10, TO PROVIDE THAT A GRADING PERMIT GENERALLY WILL AUTHORIZE THE GRADING OF NO MORE THAN 120 ACRES AT A TIME; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
