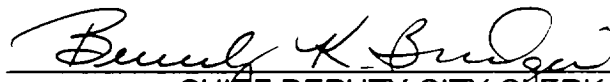

V-61-99 - OAKLEY BOULEVARD CHURCH OF CHRIST ON BEHALF OF TEMPLETON DEVELOPMENT - Appeal filed by Templeton Development Corporation from the Denial by the Board of Zoning Adjustment of a request by Oakley Boulevard Church of Christ on behalf of Templeton Development for a Variance on property located south of Del Monte Avenue, approximately 400 feet west of Valley View Boulevard TO ALLOW A PROPOSED 58,950 SQUARE FOOT CONVALESCENT CARE FACILITY 12 FEET FROM THE FRONT PROPERTY LINE WHERE 30 FEET IS THE MINIMUM FRONT SETBACK REQUIRED, AND 6 FEET FROM THE SIDE PROPERTY LINE WHERE 10 FEET IS THE MINIMUM SIDE YARD SETBACK REQUIRED; AND TO ALLOW A 57 FOOT REAR YARD SETBACK WHERE RESIDENTIAL ADJACENCY STANDARDS REQUIRE A 69 FOOT MINIMUM SETBACK, R-E (Residence Estates) Zone, Ward 1 (McDonald), APN: 162-06-603-014, LEGALLY DESCRIBED AS A PORTION OF THE SOUTHEAST QUARTER (SE¼) OF THE NORTHEAST QUARTER (NE¼) OF SECTION 6, TOWNSHIP 21 SOUTH, RANGE 61 EAST, M. D. B. & M.
