ORDINANCE NO. 5148

AN ORDINANCE RELATING TO GRANTING A FRANCHISE; GRANTING TO TELECOMMUNICATIONS OF NEVADA, L.L.C., A DELAWARE LIMITED LIABILITY COMPANY AUTHORIZED TO DO BUSINESS IN NEVADA, A NON-EXCLUSIVE FRANCHISE FOR A TELECOMMUNICATIONS SERVICE WITHIN THE CORPORATE LIMITS OF THE CITY OF LAS VEGAS, SUBJECT TO AND IN ACCORDANCE WITH THAT CERTAIN FRANCHISE AGREEMENT ENTERED INTO BETWEEN THE CITY OF LAS VEGAS AND TELECOMMUNICATIONS OF NEVADA, L.L.C.; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Grants to Telecommunications of Nevada, LLC., a non-exclusive franchise for the purpose of constructing, using and maintaining a telecommunications service within the corporate limits of the City of Las Vegas, subject to and in accordance with the terms and conditions of the Franchise Agreement between the City of Las Vegas and Telecommunications of Nevada, LLC., incorporated by reference into this Ordinance.

The above and foregoing ordinance was first proposed and read by title to the City Council on the 10th day of May, 1999 and referred to the following committee composed of Councilman Brown and Mayor Jones for recommendation; thereafter the said committee reported favorably on said ordinance on the 24th day of May, 1999, which was a regular meeting of said City Council; and that at said regular meeting the proposed ordinance was read by title to the City Council as introduced and adopted by the following vote:
