ORDINANCE NO.**

AN ORDINANCE RELATING TO THE NUMBER OF WARDS WITHIN THE CITY AND THE CORRESPONDING SEATS ON THE CITY COUNCIL; INCREASING THE NUMBER OF CITY COUNCIL WARDS AND CORRESPONDING COUNCIL SEATS FROM FOUR TO SIX; AMENDING TITLE 2, CHAPTER 2, SECTIONS 10 AND 20, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO INDICATE THE YEARS IN WHICH THE RESPECTIVE SEATS ARE UP FOR ELECTION; PROVIDING FOR THE ESTABLISHMENT OF THE BOUNDARIES OF THE ADDITIONAL WARDS AND FOR THE INTERIM APPOINTMENT OF COUNCILMEN TO REPRESENT THOSE WARDS UNTIL THE NEXT CITY GENERAL ELECTION; PROVIDING THAT THIS ORDINANCE BECOME EFFECTIVE UPON THE APPROVAL OF AN ADVISORY BALLOT QUESTION ON THE SUBJECT AT THE CITY GENERAL ELECTION IN JUNE 1999; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
