ORDINANCE NO. 5133

AN ORDINANCE RELATING TO PARKING VIOLATIONS; AMENDING TITLE 11, CHAPTER 10, SECTION 140, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW SUBSECTION, DESIGNATED AS SUBSECTION (C), TO AUTHORIZE AN ADMINISTRATIVE FEE OF \$10 TO COVER THE COSTS OF FILING AND RELEASING NOTICES OF NONPAYMENT OF CIVIL PARKING FINES THAT HAVE BEEN FILED WITH THE NEVADA DEPARTMENT OF MOTOR VEHICLES AND PUBLIC SAFETY; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Authorizes the charging of a \$10 administrative fee to cover the costs of filing and releasing notices of nonpayment of civil parking fines that have been filed with the Nevada Department of Motor Vehicles and Public Safety. adjustments in right-of-way widths and classifications.

The above and foregoing ordinance was first proposed and read by title to the City Council on the 8th day of February, 1999, and referred to the following committee composed of Councilmen Adamsen and McDonald for recommendation; thereafter the said committee reported favorably on said ordinance on the 8th day of March, 1999, which was a regular meeting of said City Council; and that at said regular meeting the proposed ordinance was read by title to the City Council as first introduced and adopted by the following vote:
