Ordinance No. 5132

AN ORDINANCE TO AMEND THE MASTER PLAN OF STREETS AND HIGHWAYS PROVIDED FOR IN TITLE 13, CHAPTER 12, SECTION 30, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO OR REMOVING THEREFROM VARIOUS RIGHTS-OF-WAY, AND BY CHANGING THE RIGHT-OF-WAY WIDTH OR CLASSIFICATION OF VARIOUS OTHER RIGHTS-OF-WAY WITHIN THE AREA ENCOMPASSED BY THAT PLAN; PROVIDING FOR OTHER MATTERS RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Amends the Master Plan of Streets and Highways to make numerous adjustments in right-of-way widths and classifications.

The above and foregoing ordinance was first proposed and read by title to the City Council on the 9th day of November, 1998, and referred to the following committee composed of Councilmen McDonald and Brown for recommendation; thereafter the said committee reported favorably on said ordinance on the 8th day of March, 1999, which was a regular meeting of said City Council; and that at said regular meeting the proposed ordinance was read by title to the City Council as amended and adopted by the following vote:
