Pursuant to Title 9, Chapter 12 of the Las Vegas Municipal Code. NOTICE IS HEREBY GIVEN THAT ON **Monday, January 25, 1999**, at the hour of **2:00 P.M.**, in the Council Chambers, City Hall Complex, 400 East Stewart Avenue, Las Vegas, Nevada, the City Council will consider the following REPORT OF EXPENSES submitted by the Director of Neighborhood Services incurred by the City of Las Vegas for:

Abatement of the property by removal of all litter, trash and debris, located at **6272, 6273, 6276, 6277 Desert Haven Road and 6252, 6264, 6280, 6288 Fisher Avenue**, legally described as **Breckenridge, Plat Book 65, Page 41, Lots 2, 3, 4, 5, 19, 20, 21, 22, Block 1**. Owner of record at time of abatement: TRUSTEE CLARK COUNTY TREASURER

The Director of Neighborhood Services certifies in the report that the sum of \$2,891.04 was expended (\$2,513.95 to Weaver Construction for cleaning the premises, Administrative processing fee \$377.09).

Abatement of the property by removal of all litter, trash and debris, located at **708 Madison Avenue**, legally described as **HFM & M ADD, Plat Book 1, Page 47, Lot 4, Block 29**. Owner of record at time of abatement: TRUSTEE CLARK COUNTY TREASURER

The Director of Neighborhood Services certifies in the report that the sum of \$1,037.53 was expended (\$902.20 to Weaver Construction for cleaning the premises, Administrative processing fee \$135.33).

If upon hearing the report, the City Council is satisfied with the correctness of the expenses incurred by the City, it may order a lien of assessment recorded and given to the County Treasurer to be collected in the same manner as ordinary property taxes.

Any person interested in or affected by the proposed charge may file written protests or objections with the City Clerk at any time prior to the time set for the hearing on the Report of Expenses. Each such protest or objection must contain a description of the property in which the signer thereof is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protest or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.
