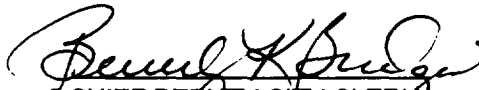

NOTICE IS HEREBY GIVEN THAT on Wednesday, December 6, 2000, at the hour of 1:00 P.M. in the Council Chambers, 400 Stewart Avenue, Las Vegas, Nevada, the City Council will consider the following Vacation Requests:

VAC-0030-00 - PALACE STATION HOTEL & CASINO, INC. - Petition to vacate of Kings Way generally located between Teddy Drive and Rancho Drive, and excess right-of-way of Rancho Drive generally located south of Sahara Avenue, LEGALLY DESCRIBED AS KINGS WAY, A SIXTY FOOT (60') WIDE PUBLIC RIGHT-OF-WAY, EXTENDING FROM THE EAST RIGHT-OF-WAY LINE OF TEDDY DRIVE TO THE WEST RIGHT-OF-WAY LINE OF RANCHO DRIVE, INCLUDING THE SPANDREL AREAS; AND EXCESS DEDICATED PUBLIC RIGHT-OF-WAY OF THE WEST HALF OF RANCHO DRIVE, VARYING IN WIDTH, COMMENCING AT A POINT APPROXIMATELY TWO HUNDRED AND TWENTY (220') FEET SOUTH OF THE SOUTH RIGHT-OF-WAY LINE OF SAHARA AVENUE AND EXTENDING SOUTHWESTERLY APPROXIMATELY 1,200 FEET; SAID PROPERTY BEING A PORTION OF THE EAST HALF (E½) OF THE NORTHEAST QUARTER (NE¼) OF SECTION 8, TOWNSHIP 21 SOUTH, RANGE 61 EAST, M.D.M.
