Abatement of the dangerous building by securing, boarding of the building and removing all litter, trash and debris on property located at **1817 STEWART AVENUE** legally described as **BOULDER DAM HOMESITE ADD TRACT #02, PLAT BOOK 1 PAGE 76**. The Director of Neighborhood Services certifies in the report that the sum of \$917.60 was expended (\$797.92 to Weaver Construction for securing the vacant building, and removing all litter, trash and debris on the property and \$119.68 Administrative Processing Fee).

Abatement of the dangerous building by securing, boarding of the building and removing all litter, trash and debris on property located at **3009 ROSEVILLE WAY** legally described as **RICHFIELD VILLAGE UNIT #4B, PLAT BOOK 9, PAGE 18, LOT 20, BLOCK 10**. Abatement of the dangerous building by securing, boarding of the building and removing all litter, trash and debris on property located at **1813 EUCLID AVENUE** legally described as **EASTWOOD TRACT #2, PLAT BOOK 3, PAGE 84, LOT 14, BLOCK 4**. Owner of record at time of abatement: **VERA L. LOVELADY- Ward 3 (REESE)**

The Director of Neighborhood Services certifies in the report that the sum of \$1,766.40 was expended (\$1,536.00 to K. O. Construction, Inc. for securing the vacant building, and removing all litter, trash and debris on the property and \$230.40 Administrative Processing Fee).

If upon hearing the report, the City Council is satisfied with the correctness of the expenses incurred by the City, it may order a lien of assessment recorded and given to the County Treasurer to be collected in the same manner as ordinary property taxes.

Any person interested in or affected by the proposed charge may file written protests or objections with the City Clerk at any time prior to the time set for the hearing on the Report of Expenses. Each such protest or objection must contain a description of the property in which the signer thereof is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protest or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.
