VAC-0004-00 - COX COMMUNICATIONS OF LAS VEGAS, INC. - Petition for a Vacation to vacate excess right of way generally located at the northeast intersection of Rancho Drive and Bonanza Road from Ernest May Lane to Dike Lane, Ward 5 (Weekly), LEGALLY DESCRIBED AS EXCESS DEDICATED PUBLIC RIGHT-OF-WAY, VARYING IN WIDTH, FROM THE WEST RIGHT-OF-WAY LINE OF DIKE LANE EXTENDING NORTHWESTERLY ALONG THE EAST SIDE OF RANCHO DRIVE TO THE SOUTH RIGHT-OF-WAY LINE OF ERNEST WAY; SAID PROPERTY BEING A PORTION OF THE NORTH HALF (N $\frac{1}{2}$) OF THE SOUTHEAST QUARTER (SE $\frac{1}{4}$) OF SECTION 29, TOWNSHIP 20 SOUTH, RANGE 61 EAST, M.D.M.
