VAC-0003-01 - GREENGALE PROPERTIES, LIMITED LIABILITY COMPANY ON BEHALF OF JEFF GALE - Petition to Vacate Rio Vista Street between Haley Avenue and Dorrell Lane, and Haley Avenue between Tenaya Way and Rio Vista Street, Ward 6 (Mack), LEGALLY DESCRIBED AS THE WEST THIRTY FEET (30') OF RIO VISTA STREET FROM THE CENTERLINE OF DORRELL LANE TO THE NORTH RIGHT-OF-WAY LINE OF HALEY AVENUE INCLUDING THE SPANDREL AREAS; AND THE NORTH THIRTY FEET OF HALEY AVENUE FROM THE CENTERLINE OF RIO VISTA STREET TO THE EAST RIGHT-OF-WAY LINE OF TENAYA WAY INCLUDING THE SPANDREL AREAS, SAID PROPERTIES BEING A PORTION OF THE SOUTHWEST QUARTER (SW¼), OF THE NORTHEAST QUARTER (NE¼) OF SECTION 22, TOWNSHIP 19 SOUTH, RANGE 60 EAST, M.D.M.
