**NOTICE OF PUBLIC HEARING
APRIL 17, 2002**

Pursuant to Title 9, Chapter 12 of the Las Vegas Municipal Code, NOTICE IS HEREBY GIVEN THAT ON **Wednesday, April 17, 2002** at the hour of **1:00 P.M.**, in the Council Chambers, City Hall Complex, 400 Stewart Avenue, Las Vegas, Nevada, the City Council will consider the following REPORT OF EXPENSES submitted by the Director of Neighborhood Services incurred by the City of Las Vegas for:

Abatement of the property by cleaning and removing all inoperable vehicles and non-approved stored vehicles; removing all outside storage; and all litter, trash and debris on property located at **1368 PYRAMID DRIVE** legally described as **TWIN LAKES VILLAGE UNIT 4, PLAT BOOK 4, PAGE 98, PT LOT 51, BLOCK 19** Owner of record at time of abatement: **WILLIE B. JAQUESS(SHIRLEY AYO, LEGAL GUARDIAN) – WARD 5 (WEEKLY)**

The Director of Neighborhood Services certifies in the report that the sum of \$1,950.40 was expended (\$1,696.00 to K. O. Construction for cleaning the property and \$254.40 Administrative Processing Fee).

If upon hearing the report, the City Council is satisfied with the correctness of the expenses incurred by the City, it may order a lien of assessment recorded and given to the County Treasurer to be collected in the same manner as ordinary property taxes.

Any person interested in or affected by the proposed charge may file written protests or objections with the City Clerk at any time prior to the time set for the hearing on the Report of Expenses. Each such protest or objection must contain a description of the property in which the signer thereof is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protest or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.
