The Director of Neighborhood Services certifies in the report that the sum of \$1,139.00 was expended (\$1,064.00 to Weaver Construction for securing and cleaning the premises and \$75.00 Administrative Processing fee).

Abatement of the dangerous building by repairing and replacement of electrical systems on property located at 1500 1/2 LAMB BLVD, legally described as PARCEL 140-29-101 002 PT NW4, NW4, SEC 29 20 67. Owner of record at time of abatement: ROMER TRUST, HERBERT D. POMER TRS.

The Director of Neighborhood Services certifies in the report that the sum of \$68,713.33 was expended (\$67,963.33 to Roberts Electric Company, Inc. For the work done and \$750.00 Title Report).

Each such protest or objection must contain a description of the property in which the signer there of is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protest or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.
