Abatement of the dangerous building by demolition, cleaning the premises on property located at 610 W. ADAMS, legally described as H.F.M. & M. ADD, PLAT BOOK 1, PAGE 4, LOT 4, BLOCK 18. Owner of record at time of abatement: CALLIE SIMPSON.

The Director of Neighborhood Services certifies in the report that the sum of \$6,602.82 was expended (\$5,741.52 to Kopf Construction for demolition and cleaning the premises; Administrative processing fee \$861.30).

Abatement of the dangerous building by demolition, cleaning the premises on property located at 4313 FAIRWOOD AVENUE, legally described as CHARLESTON HEIGHTS, TRACT #40B, PLAT BOOK 7, PAGE 30, LOT 22, BLOCK 5. Owner of record at time of abatement: ALLEN F. JOHNSON.

The Director of Neighborhood Services certifies in the report that the sum of \$8,122.25 was expended (\$7,062.80 to Kopf Construction for demolition and cleaning the premises; Administrative processing fee \$1059.45).

Abatement of the dangerous building by demolition, cleaning the premises on property located at 1176 MILLER AVENUE, legally described as VEGAS HEIGHTS, TRACT UNIT #4, PLAT BOOK 1, PAGE 77, LOT 149C. Owner of record at time of abatement: LEWIS H. TENNIS.

The Director of Neighborhood Services certifies in the report that the sum of \$4,866.73 was expended (\$4,231.92 to Kopf Construction for demolition and cleaning the premises; Administrative processing fee \$634.82).

If upon hearing the report, the City Council is satisfied with the correctness of the expenses incurred by the City, it may order a lien of assessment recorded and given to the County Treasurer to be collected in the same manner as ordinary property taxes.

Any person interested in or affected by the proposed charge may file written protests or objections with the City Clerk at any time prior to the time set for the hearing on the Report of Expenses. Each such protest or objection must contain a description of the property in which the signer thereof is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protest or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.
