U-54-97(2) APPEAL FILED BY GORDON & SILVER, LTD. ON BEHALF OF RESORT AT SUMMERLIN AN LIMITED PARTNERSHIP from the Denial by the Planning Commission of a request for an amendment to an approved Special Use Permit on property located on the southwest corner of Summerlin Parkway and Rampart Boulevard, which allowed 324,288 square feet of structures, including a 50,000 square foot casino, one six-story, 390 room hotel and a two-story parking garage. PROPOSED AMENDMENT: A SECOND SIX-STORY, 300 ROOM HOTEL. A TOTAL OF 452,360 SQUARE FEET OF STRUCTURES AND A FOUR-STORY 1,000 SPACE PARKING GARAGE. NOTE: THIS AMENDMENT WILL NOT EXPAND THE FLOOR SPACE OF THE PROPOSED CASINO. PC (Planned Community) Zone, Ward 2 (Adamsen). APN: 138-29-401-002. 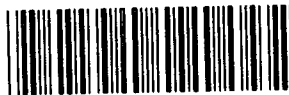
