U-54-96(7) APPEAL FILED BY GORDON & SILVER, LTD. ON BEHALF OF RESORT AT SUMMER LIN, LIMITED PARTNERSHIP from the Denial by the Planning Commission on a request for an amendment to an approved Special Use Permit on property located on the southwest corner of Summerlin Parkway and Rampart Boulevard which dilutes 324,268 square feet of structures, including a 50,000 square foot casino, one six-story 300 room hotel and a two-story parking garage. PROPOSED AMENDMENT: A SECOND SIX-STORY 300 ROOM HOTEL. A TOTAL OF 452,560 SQUARE FEET OF STRUCTURES AND A FOUR-STORY 1,000 SPACE PARKING GARAGE. NOTE: THIS AMENDMENT WILL NOT EXPAND THE FLOOR SPACE OF THE PROPOSED CASINO. PC (Planned Community) Zone, Ward 2 (Adamsen). APN: 138-29-401-002, LEGALLY DESCRIBED AS BEING A PORTION OF THE SOUTH HALF (S½) OF THE SOUTHWEST QUARTER (SW¼) OF SECTION 29, TOWNSHIP 20 SOUTH, RANGE 60 EAST, M.D.B. & M.

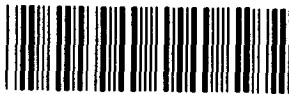
