Note: A budget augmentation for the General Fund was approved by Council on January 8, 1997 in the amount of \$3,929,259. The City also issued General Obligation Medium Term Recreation Bonds February 1, 1997 in the amount of \$10,500,000 for the purpose of acquiring, constructing, equipping and improving Park and Recreation projects in the City, with a ten year term limit.
