NOTICE IS HEREBY GIVEN THAT on Wednesday, December 18, 1996, at the hour of 2:00 P.M. in the Council Chambers, City Hall Complex, 400 East Stewart Avenue, Las Vegas, Nevada, the City Council will review the following Petitions for Vacation:

VAC-46-96 - RANCHO-ROWLAND PARTNERSHIP to vacate a portion of a dedicated frontage road on the east side of Rancho Drive from a point approximately 600 feet north of the north right-of-way line of Duncan Drive northerly approximately 200 feet, Ward 4 (Collister).
