SCOPE OF WORK: The work to be performed under this contract consists of roadway improvements to Buffalo Drive between Washington Avenue and Atwood Avenue and to Cheyenne Avenue between U.S. 95 and Cimarron Road in the City of Las Vegas, Clark County, Nevada. Improvements include removal of A.C. pavement, cold planing, roadway excavation, placement and compaction of base material, A.C. paving, A.C. overlay, curb, gutter, sidewalk, asphalt and concrete roadway medians, storm drain improvements, sanitary sewer improvements, waterline installation, traffic signage, installation of and modifications to traffic signals, and traffic pavement markings.

The estimated monetary range of the project is: \$6,500,000 to \$7,000,000.
