A MEDIUM TERM OBLIGATION

NOTICE is hereby given that the City Council of the City of Las Vegas, Nevada (the "Council" and "City", respectively) will hold a public hearing of a regular meeting to be held on Wednesday, December 4, 1996 at the hour of 2:00 p.m. in the Council Chambers, Las Vegas City Hall Complex, 400 East Stewart, Las Vegas, Nevada to act upon a resolution authorizing medium term financing of the City in the maximum principal amount of \$10,500,000 to enable the Council to pay all or a portion of the cost of acquiring, constructing, equipping and improving park and recreation projects for City purposes; including, but not limited to, community centers to be located within the City.

The loan is not proposed to be repaid in whole or in part by the levy of a tax exempt from the limitations on taxes and valuations, but is to be repaid from legally available funds of the City, including, without limitation, supplemental city-county relief taxes and available monies in the City's parks and leisure activities capital projects fund and general fund.

The term of the resolution authorizing such medium term financing, to be considered by the Council after such hearing and other information concerning such medium term financing and the purpose for which it is proposed to be used, may be examined in the office of the City Clerk, City Hall Complex, 400 East Stewart, Las Vegas, Nevada. All persons are invited to attend and to be heard regarding the proposed action. Prior to the hearing, written comments may be filed with the City Clerk at the aforementioned address.
