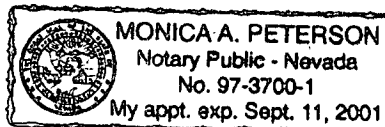

MSH-6-98 - PERMA-BILT HOMES - Request to Amend the Master Plan of Streets and Highways to remove the Borden (Barden) Road alignment between Gilmore Avenue and Gowan Road; and to reduce the planned right-of-way width to Hualapai Way, between Cheyenne Avenue and Alexander Road, from 100 feet to 80 feet.
