NOTICE IS HEREBY GIVEN that a petition has been filed with the Clerk of the City Council of the City of Las Vegas, Nevada, asking for the relinquishment of the City's interest in certain real property hereinafter described; that said petition has been referred to the Planning Commission of the City of Las Vegas; and that said Planning Commission has recommended that said petition be approved and that the City's interest in the following property be relinquished, to-wit:

U.S. Government Patent Reservations generally located on the northwest corner of Vegas Drive and Tenaya Way.

SUBJECT TO:

1. Conformance to code requirements and design standards of all City departments;
2. The Order of Relinquishment shall not be recorded until all of the above conditions have been met;
3. If the Order of Relinquishment is not recorded within one (1) year after approval by the City Council or an extension is not granted by the Planning Commission, then approval will terminate and a new petition must be submitted.

A PUBLIC HEARING on said petition and recommendation of the Planning Commission will be held on the 7th day of December, 1988, at the hour of 2:00 p.m., in the Council Chambers of City Hall, 400 East Stewart Avenue, Las Vegas, Nevada, County of Clark, State of Nevada.

If, upon such hearing, the City Council of the City of Las Vegas is satisfied that the public will not be materially injured by such proposed relinquishment of interest, the City's interest in the above-described property will be ordered relinquished.
