ORDER DECLARING ELECTION

WHEREAS, it appears that Article 5 of the Charter of the City of Las Vegas, Nevada, requires that a primary municipal election be held on the Tuesday after the first Monday in May, 1991, and that a general municipal election be held on the Tuesday after the first Monday in June, 1991, in the City of Las Vegas, Nevada, for the nomination and election, respectively, by the registered voters of the City of a:

MAYOR;
MUNICIPAL JUDGE, DEPT. 1;
MUNICIPAL JUDGE, DEPT. 4;
MUNICIPAL JUDGE, DEPT. 6;

and by the registered voters of the respective Wards of a:
CITY COUNCILMAN, WARD 1;
CITY COUNCILMAN, WARD 3;

NOW, THEREFORE, IT IS HEREBY ORDERED by the City Council of the City of Las Vegas, Nevada, that a PRIMARY MUNICIPAL ELECTION be held in the CITY OF LAS VEGAS, NEVADA, on Tuesday, May 7, 1991, at which election there shall be nominated by the registered voters of said City a MAYOR; MUNICIPAL JUDGE, DEPT. 1; MUNICIPAL JUDGE, DEPT. 4; and MUNICIPAL JUDGE, DEPT. 6; and by the registered voters of the respective Wards a CITY COUNCILMAN, WARD 1 and CITY COUNCILMAN, WARD 3.

IT IS FURTHER ORDERED that a GENERAL MUNICIPAL ELECTION be held in the CITY OF LAS VEGAS, NEVADA, on Tuesday, June 4, 1991, at which election there shall be elected by the registered voters of said City a MAYOR; MUNICIPAL JUDGE, DEPT. 1; MUNICIPAL JUDGE, DEPT. 4; and MUNICIPAL JUDGE, DEPT. 6; and by the registered voters of the respective Wards a CITY COUNCILMAN, WARD 1 and CITY COUNCILMAN, WARD 3; all of whom shall be elected and hold office for a period of four (4) years and until their respective successors are elected and qualified, and at which election there shall be voted upon by the registered voters of said City the question of WHETHER OR NOT SAID CITY SHALL ISSUE NOT TO EXCEED FIFTEEN MILLION DOLLARS (\$15,000,000) IN AGGREGATE PRINCIPAL AMOUNT OF SAID CITY'S GENERAL OBLIGATION BONDS FOR THE PURPOSE OF EXPANDING THE CITY'S MUNICIPAL COURT FACILITIES.

IT IS FURTHER ORDERED that the places in said City at which the votes in said elections may be cast are hereby determined as follows:
