FIRST AMENDMENT
 BILL NO. 88-35
 ORDINANCE NO. 3241
 AN ORDINANCE RELATING TO BUSINESS LICENSING; AMENDING TITLE 6, CHAPTER 64 THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY REPEALING SECTION 70, REQUIRING THE POSTING OF A BOND BY PRIVATE INVESTIGATORS, PRIVATE PATROLMEN, PROCESS SERVERS, POLYGRAPH OPERATORS, REPOSSESSORS AND CANINE SECURITY HANDLERS; AMENDING SECTIONS 10, 20, 30, 40, 80, 90 AND 100 OF SAID TITLE AND CHAPTER TO MAKE THEIR DEFINITIONS AND TERMINOLOGY CONSISTENT WITH CHAPTER 648 OF THE NEVADA REVISED STATUTES; PROVIDING FOR OTHER MATTERS RELATED THERETO; AND REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

 Summary: Eliminates bond requirement for private investigators, private patrolmen, process servers, polygraph operators, repossessors and canine security handlers; makes language of chapter consistent with state law governing these occupations.

The above and foregoing ordinance was first proposed and read by title to the City Council on the 2nd day of July, 1986, and referred to the following committee composed of Councilmen Lurie and Levy for recommendation; thereafter the said committee reported favorably on said amended ordinance on the 8th day of August, 1986, which was a regular meeting of said Council; that at said regular meeting, the proposed ordinance was read by title to the City Council as amended and adopted by the following vote:
