following property be vacated, to-
wit:
Government Patent Reservations on
property generally located east of
Buffalo Drive and North of Westcliff
Drive.
SUBJECT TO
1. Reservation of easements for the
facilities of the various utility com-
panies, together with reasonable in-
gress thereto and egress therefrom;
2. Conformance to code require-
ments and design standards of all
City departments;
