AN ORDINANCE OF THE CITY OF LAS VEGAS CONCERNING LICENSE TAXES FOR REVENUE; ASSIGNING THE PROCEEDS OF SUCH TAXES AS ARE LEVIED UPON HOTELS, MOTELS AND UPON CERTAIN OTHER SHORT-TERM RENTAL UNITS AND UPON GAMING TO CLARK COUNTY FOR PLEDGE TO THE PAYMENT OF THE CLARK COUNTY, NEVADA, GENERAL OBLIGATION (LIMITED TAX) LAS VEGAS CONVENTION AND VISITORS AUTHORITY BUILDING BONDS (ADDITIONALLY SECURED WITH PLEDGED REVENUES) SERIES JUNE 1, 1988; CONSENTING AND AGREEING TO BE BOUND BY THE PROVISIONS OF THE LAS VEGAS CONVENTION AND VISITORS AUTHORITY'S RESOLUTION AUTHORIZING THEIR ISSUANCE, DESIGNATED BY THE SHORT TITLE "6-1-88 BOND RESOLUTION," TO THE EXTENT IT APPERTAINS TO THE CITY OF LAS VEGAS; RATIFYING, APPROVING AND CONFIRMING ACTIONS HERETOFORE TAKEN IN THE AUTHORITY'S BORROWING AND IN THE IMPOSITION, COLLECTION AND ASSIGNMENT OF SUCH TAXES AND THEIR PLEDGE TO SAID BONDS; AUTHORIZING THE ISSUANCE OF SAID BONDS; AND DESCRIBING OTHER DETAILS IN CONNECTION THEREWITH AND WITH SAID BONDS.
