

NOTICE OF PUBLIC HEARING  
NOVEMBER 2, 1988

NOTICE IS HEREBY GIVEN that on Wednesday, November 2, 1988, at the hour of 2:00 P.M., in the Council Chambers, City Hall Complex, 400 East Stewart Avenue, Las Vegas, Nevada, the City Council will consider a report by the Director of Building & Safety of the expense incurred by the City of Las Vegas to abate the dangerous building and clean the premises on property located at 301 Harrison Avenue. This hearing is being scheduled pursuant to Section 902 of the Uniform Code for the Abatement of Dangerous Buildings, adopted as Section 16.08.010 of the Las Vegas Municipal Code.

The above property is legally described as:

VALLEY VIEW ADDITION, LOT 12, BLOCK 9

The Director of Building & Safety certifies in the report that the sum of \$1,207.00 was expended to Weaver Construction Company for the abatement of the dangerous building and the cleaning of the premises on property located at 301 Harrison Avenue. If upon hearing the report, the City Council is satisfied with the correctness of the expenses incurred by the City it may order a lien of assessment recorded and given to the County Treasurer to be collected in the same manner as ordinary property taxes.

Any persons interested in or affected by the proposed charge may file written protests or objections with the City Clerk at any time prior to the time set for the hearing on the report of the Director of Building & Safety. Each such protest or objection must contain a description of the property in which the signer thereof is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protests or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.
