Pursuant to Section 902 of the Uniform Code for the Abatement of Dangerous Buildings, adopted as Section 16.08.010 of the Las Vegas Municipal Code, NOTICE IS HEREBY GIVEN THAT ON WEDNESDAY, JANUARY 6, 1993, at the hour of 2:00 P.M., in the Council Chambers, City Hall Complex, 400 East Stewart Avenue, Las Vegas, Nevada, the City Council will consider the following REPORT OF EXPENSES submitted by the Director of Building & Safety incurred by the City of Las Vegas for:

Abatement of the dangerous building by boarding, securing and cleaning the premises on property located at 633 N. 12TH STREET, legally described as TANKELSNORTH ADDITION AMENDED, PLAT BOOK 5, PAGE 14, LOT 3, BLOCK 33 & PORTION OF LOT 22. Owner of record at time of abatement: AINSWORTH, INC., C/O MR. & MRS. HAMILTON. The Director of Building and Safety certifies in the report that the sum of \$2,997.94 was expended to Las Vegas Demolition for securing and cleaning the property.

Abatement of the dangerous building by boarding, securing and cleaning the premises on property located at 637 N. 12TH STREET, legally described as TANKELSNORTH ADDITION AMENDED, PLAT BOOK 5, PAGE 14, LOT 2, BLOCK 33. Owner of record at time of abatement: CLARK COUNTY TREASURER, TRUSTEE. The Director of Building and Safety certifies in the report that the sum of \$2,449.83 was expended to Las Vegas Demolition for securing and cleaning the property.

If upon hearing the report, the City Council is satisfied with the correctness of the expenses incurred by the City, it may order a lien of assessment recorded and given to the County Treasurer to be collected in the same manner as ordinary property taxes.

Any person interested in or affected by the proposed charge may file written protests or objections with the City Clerk at any time prior to the time set for the hearing on the Report of Expenses. Each such protest or objection must contain a description of the property in which the signer thereof is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protest or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.

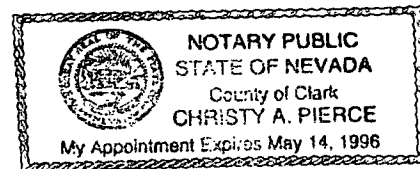
