1. LISTED BELOW ARE SIGNIFICANT VIOLATIONS  
 OF WASTEWATER DISCHARGE VIOLATIONS  
 OF THE REQUIREMENTS OF 40 CFR PART  
 403 (GENERAL INDUSTRIAL WASTE PRE-  
 TREATMENT & REGULATIONS) OCCURRING  
 OVER THE PAST 12 MONTHS.

2. INDUSTRY NAME: SJOB PAVING  
 ADDRESS: 412 North Martin Luther  
 King Blvd., Las Vegas, NV 89106

VIOLATION: 1. Exceeded limitations  
 requirements specified in the Waste-  
 water Contribution Permit No. 87-001  
 for CADMIUM. Violation based on  
 samples taken on January 10, 1989.

2. Violation for not meeting require-  
 ments given by the Control Authority  
 under a Revocation and Stay Order  
 ordered by the Council of the City of  
 Las Vegas on January 4, 1989. That  
 stay was subject to the condition that  
 there be no further violations of  
 the Wastewater Contribution Permit No.  
 87-001.

ACTION TAKEN: After a public  
 hearing before the City of Las Vegas  
 Council for previous violations, SJOB  
 Paving did not take the appropriate  
 precautions to comply with the Fed-  
 eral Standards and Limitations. The

City Council, therefore, on its meet-  
 ing on Wednesday, February 15,  
 1989, dissolved the stay and directed  
 that the previously ordered Revoca-  
 tion be enforced.

SJOB on February 4, 1989, was not  
 certified Notice of Violation. Febru-  
 ary 12, 1989, City Council dissolved  
 the stay and ordered revocation to be  
 enforced.

February 17, 1989, certified notice of  
 stay. Permit revocation to SJOB; ordered  
 to cease and desist discharges of  
 wastewater from electroplating pro-  
 cessing to sanitary sewer system.
