Notice is hereby given that a survey map of that area in or adjacent to Sections 13, 24, 25, and 36 in Township 19 South, Range 60 East and Sections 10, 19, 30 and 31 in Township 19 South, Range 61 East, M.D.M., in Clark County, Nevada, excepting therefrom that portion of Section 36, Township 19 South, Range 60 East, M.D.M., lying south of the North Line and west of the East Line of a deed recorded in Book 2100, Document Number 2057232 of Clark County Records and further delineated on a Record of Survey in File 45, Page 33 of Surveys in the Clark County Recorder's Office, has been filed with the City Clerk of the City of Las Vegas, Nevada, on March 7, 1989.

The purpose of the filing of said survey map is to reconcile the conflict that exists as to the alignment of Decatur Boulevard between Grand Teton on the north, Jones Boulevard on the west, Lone Mountain on the south and Allen Road on the east, and its effect, if any, upon the property lines within that area.

Pursuant to NRS 270.040, the survey map and notice have been posted on the Public Bulletin Boards at the following six (6) locations:

5. North Las Vegas Police Department, 1301 E. Lake Mead Boulevard.
6. North Las Vegas Post Office, 1414 E. Lake Mead Boulevard.

Further, the notice will be published in the Las Vegas Review-Journal once a week for four (4) consecutive weeks beginning on Wednesday, March 8, 1989.

ANY AND ALL INTERESTED PERSONS who are affected by the above may file their written objections or exceptions thereto with the City Clerk, 10th floor, City Hall, said written objections shall be entitled: "Before the City Council of the City of Las Vegas, Nevada, in the Matter of the Adoption of the Survey Map of Decatur Boulevard, of and for the City of Las Vegas, Nevada." Written objections must be received by the City Clerk on or before May 7, 1989 for consideration by the City Council prior to the map being filed with the District Court in accordance with the Provisions of NRS 270.010 to 270.130 inclusive.
