

**PROCLAMATION
DECLARING ELECTION**
WHEREAS, it appears that Article 5 of the Charter of the City of Las Vegas, Nevada, requires that a primary municipal election be held on the Tuesday after the first Monday in May, 1987, and that a general municipal election be held on the Tuesday after the first Monday in June, 1987, in the City of Las Vegas, Nevada, for the nomination and election, respectively, by the registered voters of the City of a:

MAYOR;
MUNICIPAL JUDGE, DEPT. I; AND
MUNICIPAL JUDGE, DEPT. IV;
and by the registered voters of the respective Wards of a:
CITY COUNCILMAN OF WARD 1;
and
CITY COUNCILMAN OF WARD 3;
and

WHEREAS, the City Council of said City, at its regular meeting which was held on the 18th day of February, 1987, ordered that said elections be held pursuant to said Article of said Charter and that there shall be voted upon at said general election the question of whether or not said City shall issue not to exceed Five Million Five Hundred Thousand Dollars in aggregate principal amount of said City's general obligation bonds for the purposes of constructing three new fire stations, remodeling the fire training center and purchasing new fire equipment;

NOW, THEREFORE, I, WILLIAM H. BRIARE, Mayor of the City of Las Vegas, Nevada, do hereby proclaim that there shall be a:
PRIMARY MUNICIPAL ELECTION held in the CITY OF LAS VEGAS, NEVADA, on Tuesday, the 5th day of May, 1987

and a:
GENERAL MUNICIPAL ELECTION held in the CITY OF LAS VEGAS, NEVADA, a Tuesday, the 2nd day of June, 1987, at which said general election there shall be elected by the registered voters of the City of Las Vegas a MAYOR, a MUNICIPAL JUDGE, DEPT. I, and a MUNICIPAL JUDGE, DEPT. IV, and by the registered voters of the respective Wards a CITY COUNCILMAN of Ward 1 and a CITY COUNCILMAN of Ward 3 and at which election there shall be voted upon by the registered voters of said City the question of whether or not said City shall issue not to exceed Five Million Five Hundred Thousand Dollars in aggregate principal amount of said City's general obligation bonds for the purposes of constructing three new fire stations, remodeling the fire training center and purchasing new fire equipment.
