Cleaning the property located on the vacant lots north and south of 2101 Burham Avenue, legally described as METROPOLITAN ADD, AMENDED PLAT-BOOK 2, PAGE 12, LOT 15, BLOCK 1 and LOT 16, LOT 19, BLOCK 1 and LOT 20. 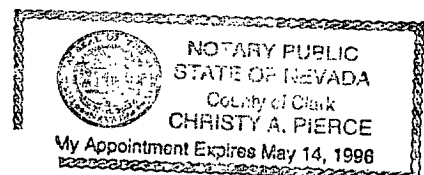
