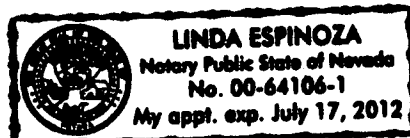

NOTICE IS HEREBY GIVEN that early voting for the April 7, 2009 Municipal Primary Elections will take place in the city of Las Vegas.

RESIDENCY REQUIREMENT

Only those voters who are registered to vote in the city of Las Vegas are eligible to vote in this election. You cannot vote in municipal elections if you are registered to vote in unincorporated areas of Clark County.

VOTING BY MAIL

Any registered voter who is eligible to vote in Las Vegas may choose to vote by mail. A written request for a mail ballot must be received by 5 p.m. on March 31, 2009. Mail ballot requests may be obtained from the Las Vegas City Clerk's Office, 400 Stewart Avenue, (702) 229-6311.

VOTING IS EASY! Las Vegas voters may vote at any of the convenient early voting sites OR on Election Day at your polling place. If you received a ballot by mail, you may surrender that ballot at any Early Vote location and vote.
