
1. Conformance to the sign elevations and documentation as submitted and date stamped 05/20/20 in conjunction with this request, except as modified herein.

3. An approved License Agreement shall be required for all signage that encroaches into the public right-of-way prior to installation of such signage.
4. Minor modifications in conformance with the approved plans and Title 19 may be approved by the Department of Planning.
