1. The Original Final Map mylar shall be in conformance with the approved Tentative Map of Savona (TM-0107-12) and all related actions, except as required by the City of Las Vegas to meet Title 19 (UDC) requirements.
2. Prior to the submittal of the original Mylar for signature by the city, the file number "FMP-54901" shall be placed above the Recorder's block in the lower right hand corner of the cover sheet.
3. Royal Antelope Drive shall be renamed Royal Antelope Street.

Please note that pursuant to Subchapter 8(C) of the City of Las Vegas Street Naming and Address Assignment Regulations, 2009 Edition, two 24" x 36" bond copies and one 8.5" x 11" reduced copy of the recorded mylar must be submitted back to the City of Las Vegas for archival purposes.

We note that many of the previous comments have been addressed. The mylar for this Final Map may be submitted provided that all the comments below are addressed.

CONDITIONS OF APPROVAL:

1. The Public Drainage Easement at the south end of Royal Antelope Street(sheet 6) must be a Public Drainage Easement and specify that it is to be privately maintained by the Homeowner's Association.
2. Contact the City Engineer's Office at 229-6272 to coordinate the development of this project with the "Rancho Road Storm Drain System - Elkhorn/Ft. Apache to Grand Canyon" project and any other public improvement projects adjacent to this site. Comply with the recommendations of the City Engineer.
3. A Covenant Running with Land Agreement, such as L-Covenant #54060, for the installation of all off-site improvements deferred at this time must record prior to recordation of this Final Map.
4. Dimensions and information presented on the approved civil improvement plans shall match the Final Map prior to recordation. Revise approved civil plans if necessary.
5. Site development to comply with all previous conditions of approval for the Savona Tentative Map (TM-107-12) and all other site related actions.
