Department of Planning staff has administratively approved your request for technical review of the subject final map, subject to the following comments and conditions:

1. The Original Final Map mylar shall be in conformance with all applicable conditions of approval for the approved Tentative Map of Granite Falls 2 (TMP-52127).
2. The Final Map shall be revised as required by the Department of Planning prior to the submittal of the original Mylar for signature by the city.
3. The file number "FMP-55481" shall be placed above the Recorder's block in the lower right hand corner of the cover sheet.
4. The map title shall be amended to "Granite Falls 2" on all sheets (remove "South"), as this map encompasses the entirety of the approved Tentative Map with this name.
5. The street name suffixes for Bruin Lakes and Powell Prairie shall be amended from "Street" to "Avenue."
6. Please correct the signature block for the Director of Planning to read as follows:

We note that an approved Drainage Plan and Technical Drainage Study update is on file with the Flood Control Section of the Department of Public Works.

CONDITIONS OF APPROVAL:

1. Per Condition #7 of TMP-52127, a Petition of Vacation, such as VAC-52125, shall record prior to the recordation of this Final Map. Alternatively, show the roadway easement on the map.
 2. Per Condition #10 of TMP-52127, the remnants of Assessor's Parcel numbers APN 125-01-402-018 and 125-01-402-017 are being incorporated into this site. Include the remnant parcels into this site and adjust the boundary of this Final Map prior to recordation.
 3. Remove the word "surface" from Easement note E1.
 4. Kristina Swallow, P.E. # 13714, is currently the Acting City Engineer. Contact the City Engineer's Office at 229-6272 prior to the submittal of the mylar of this map to determine the signature line for the City Engineer's Signature Block.
 5. Include the Final Map number, FMP-55481, above the Recorder's Block on the cover sheet.
 6. Dimensions and information presented on the approved civil improvement plans shall match the Final Map prior to recordation. Revise approved civil plans if necessary.
 7. Site development to comply with all previous conditions of approval for the Granite Falls 2 Tentative Map (TMP-52127) and all other site related actions.
