CONDITIONS OF APPROVAL:

1. Adjacent units shall record prior to this Final Map to provide legal access.
2. On sheet 2, complete all recordation information prior to recordation of this Final Map.
3. On sheet 3 symbol "E3" is not referenced in the Legend.
4. Remove Note 6 on sheet 3 and Note 4 on sheet 4 as they may become too binding in the future for the recorded map. These notes may be in conflict with maintenance criteria in the future.
5. Prior to the recordation of this Final Map, provide proof that this project has been sufficiently

coordinated with the City's "Gowan Box Canyon" project. Please contact the City Engineer's Office at 229-6272.

6. A Traffic Signal contribution of \$3,590.40 shall be paid prior to the recordation of this Final Map.
7. Include the Final Map number, FMP-71701, above the Recorder's Block on the cover sheet.
8. Dimensions and information presented on the approved civil improvement plans shall match the Final Map prior to recordation. Revise approved civil plans if necessary.
9. Site development to comply with all applicable conditions of approval for the Peaceful Ridge Tentative Map (TMP-57011).
