We note that an approved Drainage Plan and Technical Drainage Study for the Summerlin West area is on file with the Flood Control Section of the Department of Public Works. All subsequent subdivisions of this site will be required to provide individual drainage studies.

CONDITIONS OF APPROVAL:

1. Per condition #16 of TMP-76354, the property owner must contact the Special Improvement District section of the Department of Public Works (702-229-2136) prior to the release of the Final Map for recordation. The City shall prepare an apportionment report following recordation of the Final Map and this apportionment report must be signed by the property owner prior to the release of any building permits for this site.
2. Per condition #17 of TMP-76354, provide easements for all required public infrastructure (sewer, drainage, traffic) that are outside the public right-of-way. If locations are known at this time, please provide these easements on this map.

3. Include the Final Map number, FMP-78162, above the Recorder's Block on the cover sheet.
 4. Site development to comply with all applicable conditions of approval for Summerlin Village 25 (TMP 76354 and all other applicable site-related actions).
