Please revise the Owner's Certificate and Dedication per current City of Las Vegas standards.

We note that you have included a legal description for this parcel map. This is not a requirement for parcel maps in the City of Las Vegas. We further note that although this legal description may have been taken from the deed, it is insufficient to stand alone, and does not agree with your boundary. This creates an unexplained discrepancy. If you wish to include the description from the deed, please create a separate description which matches your boundary. I would prefer that you remove the description entirely.

Please ensure that all text meets the minimum size requirement of 0.1 inches.

Please show all existing easements and dedications affecting this map.
