Your Required Review of an approved Special Use Permit (SUP-72373) FOR AN ANIMAL KEEPING & HUSBANDRY USE (ONE LION AND ONE LEOPARD) WITH WAIVERS TO ALLOW A ZERO-FOOT DISTANCE SEPARATION FROM A RESIDENTIAL DWELLING WHERE 1,500 FEET IS REQUIRED AND A 30-FOOT DISTANCE SEPARATION FROM A PUBLIC PARK WHERE 1,500 FEET IS REQUIRED on 2.19 acres at 2225 Montessouri Street (APN 163-03-802-014), R-E (Residential Estates) Zone, Ward 1 (Knudsen), has been considered administratively by the Department of Planning staff.

The Department of Planning has administratively **APPROVED** your request subject to the following:

Planning

1. Approval of and conformance to the Conditions of Approval for Special Use Permit (SUP-72373) shall be required.
2. This Special Use Permit shall be reviewed in three (3) months, at which time the City may require cessation of the use. The applicant shall be responsible for notification costs of the review. Failure to pay the City for these costs may result in a requirement that the use be terminated.
3. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety.
4. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.
