AN ORDINANCE AMENDING THE SUPPLEMENTAL DOCUMENT TO THE CITY'S ADMINISTRATIVE CODE TO REPEAL AND REPLACE THE PROVISIONS PERTAINING TO THE BOARD OF APPEALS FOR PURPOSES OF ESTABLISHING TERM LIMITS FOR BOARD MEMBERS, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Amends the Supplemental Document to the City's Administrative Code to repeal and replace the provisions pertaining to the Board of Appeals for purposes of establishing term limits for Board members.
