The City Council at a regular meeting held August 17, 2011, APPROVED the request for an Extension of Time of a previously approved Site Development Plan Review (SDR-22206) FOR A COMMERCIAL DEVELOPMENT OF 30,000 SQUARE FEET OF HARDWARE STORE, 30,000 SQUARE FEET OF OFFICE SPACE, 40,000 SQUARE FEET OF COVERED STORAGE AREA, AND 60,000 SQUARE FEET OF AUTO REPAIR GARAGE (MAJOR) WITH A WAIVER OF PERIMETER LANDSCAPE REQUIREMENTS TO ALLOW A 10-FOOT WIDE BUFFER WHERE 15 FEET IS REQUIRED ALONG THE SOUTH PROPERTY LINE on 20.53 acres at 1736 West Bonanza Road (APN 139-28-302-034), C-2 (General Commercial) Zone.
