The City Council at a regular meeting held November 7, 2012, APPROVED a request for a Review of Condition of an approved Special Use Permit (SUP-8255) TO DELETE CONDITION #9 WHICH LIMITED THE HOURS OF OPERATION TO MONDAY THROUGH SATURDAY FROM 9:00 AM to 7:00 PM, SUNDAY FROM 10:00 AM TO 5:00 PM AND DECEMBER UNTIL 9:00 PM at 2200 South Rainbow Boulevard (APN 163-02-415-001), C-1 (Limited Commercial) Zone. The Notice of Final Action was filed with the Las Vegas City Clerk on November 8, 2012. This approval is subject to:

Planning

1. Condition #9 of Special Use Permit (SUP-8255) shall be deleted.
2. **The hours of operation for this business shall be limited to 9 A.M. through 9 P.M., seven days a week Monday through Saturday and 10 A.M. through 5 P.M. on Sunday. Hours may be from 9:00 A.M. to 9:00 P.M. seven days a week in December.**
3. Conformance to the conditions of Special Use Permit (SUP-8255) and all other site related actions as required by the Department of Planning and Department of Public Works.
