The City Council at a regular meeting held November 7, 2012, APPROVED the request for a Required Review of an approved Special Use Permit (SUP-36779) FOR A PROPOSED BEER/WINE/COOLER OFF-SALE ESTABLISHMENT WITHIN AN EXISTING 2,032 SQUARE-FOOT CONVENIENCE STORE AND A WAIVER TO ALLOW A 120-FOOT DISTANCE SEPARATION FROM A CHILD CARE FACILITY WHERE 400 FEET IS REQUIRED at 4401 East Bonanza Road (APN 140-32-101-014), C-1 (Limited Commercial) Zone. The Notice of Final Action was filed with the Las Vegas City Clerk on November 8, 2012. This approval is subject to:

Planning

1. Conformance to the conditions of approval of Special Use Permit (SUP-36779), as amended by Review of Condition (ROC-41902).
2. All unpermitted banners shall be removed or obtain an approved Temporary Sign Permit within 30 days of approval.
3. All window signage shall conform to Title 19.08.120, that window signs shall not cover more than 25% of the total area of all windows located on a building elevation.
4. All City Code requirements and design standards of all City Departments must be satisfied, except as modified herein.
