**RE: RQR-58974 - REQUIRED REVIEW – PUBLIC HEARING
CITY COUNCIL MEETING OF SEPTEMBER 16, 2015**

Dear Ms. Rieck:

The City Council at a regular meeting held on September 16, 2015 **APPROVED** a request for a Required Review of an approved Rezoning (Z-0100-97) FOR FIVE EXISTING OFF-PREMISE SIGNS on property bounded by U.S.95, I-15 and Grand Central Parkway (APNs 139-33-511-004 and 011; 139-33-610-014; and 139-27-410-005), PD (Planned Development) Zone, Ward 5 (Barlow).

This approval is subject to the following conditions:

Planning

1. Conformance to the conditions of Rezoning (Z-0100-97).
2. This Rezoning (Z-0100-97) shall be reviewed in three (3) years, at which time the City Council may require the Off-Premise Sign be removed. The applicant shall be responsible for notification costs of the review. Failure to pay the City for these costs may result in a requirement that the Off-Premise Sign is removed.
3. The Off-Premise Signs and its supporting structures shall be properly maintained and kept free of graffiti at all times. Failure to perform the required maintenance may result in fines and/or removal of the Off-Premise Signs.
4. If the existing Off-Premise Signs are voluntarily demolished, this Rezoning shall be expunged and a new Off-Premise Signs shall not be permitted in the same location unless a Special Use Permit is approved for the new structure by the City Council.

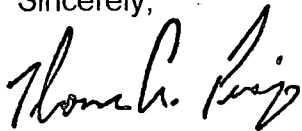
