**RE: RQR-68061 [PRJ-69497] - REQUIRED REVIEW - PUBLIC HEARING
CITY COUNCIL MEETING OF MAY 3, 2017**

Dear Mr. Levine:

The City Council at a regular meeting held on May 3, 2017 voted to *APPROVE* Required Review of a Special Use Permit (SUP-16947) FOR A 40-FOOT TALL, 14-FOOT BY 48-FOOT OFF-PREMISE SIGN at 4604 Meadows Lane (APN 139-31-110-002), C-1 (Limited Commercial) Zone, Ward 1 (Tarkanian) [PRJ-69497].

This approval is subject to the following conditions:

Planning

- 1 Conformance to the approved conditions for Special Use Permit (SUP-16947), Site Development Plan Review (SDR-57102) and amended by Review of Condition (RQR-54821), if approved.
- 2 This Special Use Permit shall be reviewed in 3 years, at which time the City Council may require the Off-Premise Sign be removed. The applicant shall be responsible for notification costs of the review. Failure to pay the City for these costs may result in a requirement that the Off-Premise Sign be removed.
- 3 The Off-Premise Sign and its supporting structure shall be properly maintained and kept free of graffiti at all times. Failure to perform the required maintenance may result in fines and/or removal of the Off-Premise Sign.
4. The property owner shall keep the property properly maintained and graffiti-free at all times. Failure to perform required maintenance may result in fines and/or removal of the Off-Premise Sign.
- 5 Bird deterrent devices shall be installed on the sign within 30 days of final approval by the City of Las Vegas.

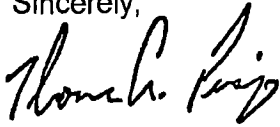

6. If the existing Off-Premise Sign is voluntarily demolished, this Special Use Permit shall be expunged and a new Off-Premise Sign shall not be permitted in the same location unless a Special Use Permit is approved for the new structure by the City Council.
7. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein
