Dear Ms. Shevorski:

The City Council at a regular meeting held on August 21, 2019 voted to **APPROVE** a request for a Summerlin Major Deviation TO ALLOW A THREE-FOOT TO EIGHT-FOOT OR 18-FOOT GARAGE DOOR SETBACK WHERE THREE FEET TO FIVE FEET OR 18 FEET IS REQUIRED ON LOT #352 OF A 421-LOT SINGLE-FAMILY RESIDENTIAL DEVELOPMENT on a portion of 103.82 acres on the south side of Crossbridge Drive, approximately 2,700 feet south of Sun Creek Drive (APN 164-04-511-001), P-C (Planned Community) Zone, Ward 2 (Seaman) [PRJ-76194].

This approval is subject to the following conditions:

Planning

1. Approval of and conformance to the Conditions of Approval for Major Modification (MOD-76513) and Tentative Map (TMP-76536) shall be required, if approved.
2. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
3. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Department of Building and Safety.
4. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.

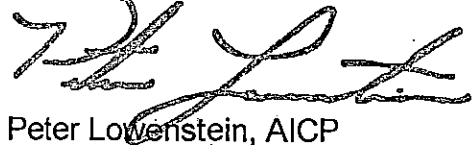
