Your request for a Minor Amendment of an approved Site Development Plan Review (SDR-72130) FOR A PROPOSED TWO-STORY, 22-UNIT MULTI-FAMILY RESIDENTIAL DEVELOPMENT on 1.34 acres at the southwest corner of Vegas Drive and Cimarron Road (APN 138-28-101-011), R-3 (Medium Density Residential) Zone, Ward 2 (Seroka) [PRJ-73264], has been considered administratively by the Department of Planning staff.

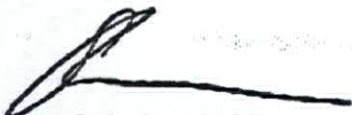
5. All City Code requirements and design standards of all City Departments must be satisfied, except as modified herein.
