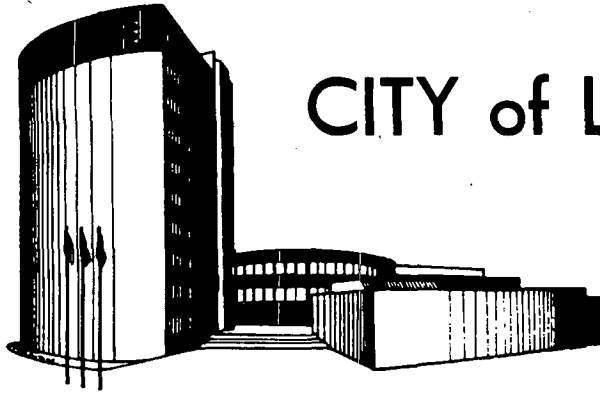

The City Council at a regular meeting held November 7, 1990 APPROVED the request for satellite parking for a proposed banquet and reception facility on property located at 4101 West Charleston Boulevard, C-1 Zone, subject to:

1. The banquet and reception facility is limited to a maximum of 3,500 square feet.
2. The banquet and reception facility use shall cease upon expiration or termination of the satellite parking lease.
3. Prior to the use of the satellite parking site, construct full-width alley paving between the end of the existing alley paving that connects to Hinson Street and the west property line of the nursery site approximately 180 feet as required by the Department of Public Works.
4. Conformance to the plot plan as amended by the above conditions.

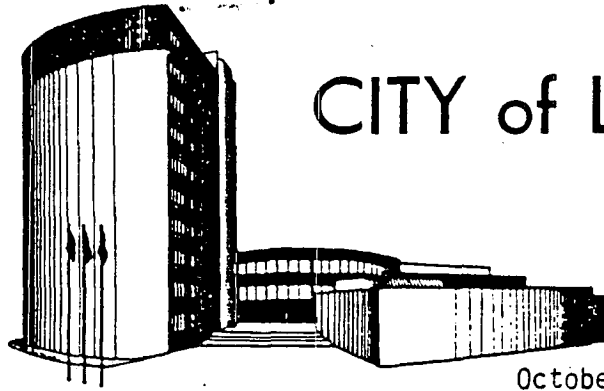

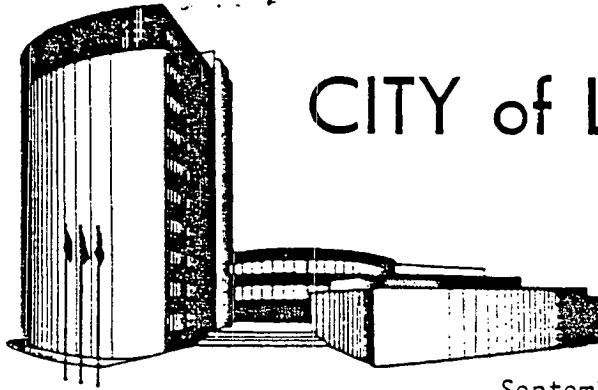

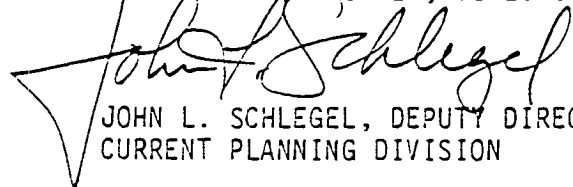
Dear Mr. and Mrs. Hulsey:
